Types of data we collect

Google Analytics

When someone visits either of our newspaper websites including www.feweek.co.uk and www.schoolsweek.co.uk, we use a third-party service, Google Analytics, to collect standard internet log information and details of visitor behaviour patterns. We do this to find out things such as the number of visitors to the various parts of the site. This information is only processed in a way which does not identify anyone. We do not make, and do not allow Google to make, any attempt to find out the identities of those visiting our website.

Mailing Lists

As part of the registration process for any of our email newsletters, we collect personal information. We use that information for a couple of reasons: to deliver our newsletters; to contact you if we need to obtain or provide additional information; to check our records are correct. We do not sell, rent or trade email lists with other companies and businesses for marketing purposes.

We use a third-party provider, MailChimp, to deliver our newsletters. We gather statistics around email opening and clicks using industry standard technologies to help us monitor and improve our newsletters. For more information, please see MailChimp's privacy notice.
